Lorraine Attreed is professor of history at the College of the Holy Cross in Worcester, Massachusetts. Presently studying late medieval diplomacy of England and the Iberian world, she has published *The York House Books, 1461–1490* (1991) and *The King's Towns: Identity and Survival in Late Medieval English Boroughs* (2001).

Ina Berg is lecturer in Mediterranean archaeology at the University of Manchester, UK. Her research focuses on the archaeology of the prehistoric Cyclades. She is particularly interested in understanding how island living has shaped the islanders' lives and their relationships with the surrounding world.

Richard W. Clement is dean of libraries at Utah State University. He and Benjamin F. Taggie founded the journal *Mediterranean Studies* in 1989 and then formally incorporated the Mediterranean Studies Association in 1994.
